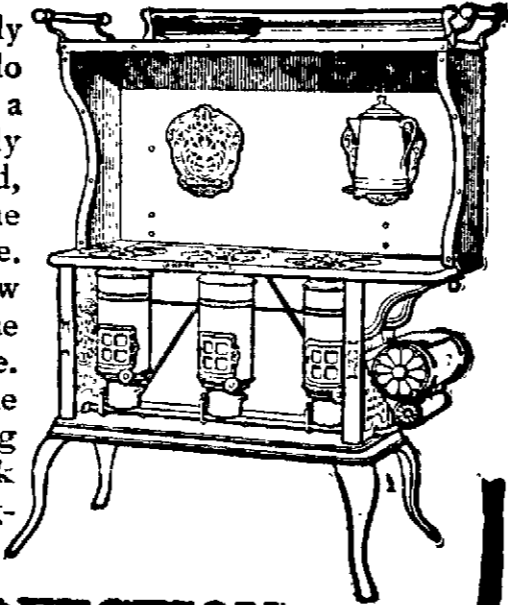
—St. Francis Xavier Beneficial Society will run an excursion to Baltimore on Thursday, April 22.
